**Vendors will not be allowed to sell any beverages other than non alcoholic beverages.**

**A Food Vendors License must be obtained from the Kent County Health Department.**

**This license must be obtained prior to your final acceptance as a vendor. This license must also be prominently on display during sales hours. An INSURANCE RIDER naming the Village of Sparta, Sparta Chamber of Commerce and Unity Security Inc must be provided prior to your final acceptance as a vendor.**
