Spaces will be filled on a first come, first served basis. We will notify you by January 31 to let you know the events that were approved, and we will send an invoice at that time for the fees. There will be a cancellation fee of 50% of the application fee if you cancel prior to two weeks before the event. Full fee will be required if you cancel two weeks or less before the event. If the event is canceled for any reason a full refund will be given. Payment options are Online Payment, Check, or Cash. All food vendors must arrive to events before they begin at the time determined and stay parked until the close of the event. Food vendors will avoid undue disturbance (such as music, loud generators, etc.).
